- 1. ACE Travel Pros assumes no responsibility for and shall not be liable for unsafe conditions or health hazards including pandemics or other illnesses. ACE Travel Pros has no special knowledge of dangers during travel or at destinations. For information related to such dangers. ACE Travel Pros recommends going to the State Department travel website at www.travel.state.gov, click on "Find International travel Information" then click on "Country Information", and fill in the name of the destination country. For medical and health information, ACE Travel Pros recommends going to the Centers for Disease Control website at www.cdc.gov/travel, then click on "Destinations" and scroll to the name of the destination country.
